MEMORANDUM OF UNDERSTANDING (MoU)

The MEMORANDUM OF UNDERSTANDING (MoU) is signed on this day of 13th Day of February, 2024 between the Barpeta Road Howly College, Howly, Assam, India represented by Dr. Bhushan Chandra Pathak, Principal of the College and Dr. Abu Sayem Siddiquee, HoD, Deptt. Of Philosophy, B. H. College, Howly, Barpea, Assam, hereafter referred as 'B. H. College' which expression shall always include its successors in title, agents or representatives or anybody claiming any rights thereto and through them or may referred as "First Party".

AND

Dr. Nijara Thakuria, HoD, Deptt. Of Philosophy, GLC College, Barpeta Road, Barpeta,
Assam Or may referred "Second Party".

The MoU between the First and Second Party contains the following:

The B.H. College, Howly, Assam, India is a College with potential for Excellence established in 1966 and Deptt. Of Philosophy, B. H. College, Howly, Barpea, Assam, is an academic department of the college. The B. H. College and the department of philosophy seek to promote educational and research activities through the development of corporative relationship between them. The Principal, B. H, College and the Head of the Philosophy Dept. of B. H. College, Howly, hereby agree to enter into this non-binding Memorandum of Understanding (MoU) that enables to work together for building the Academic and Educational Partnership between the two institutions. AND WHEREAS it is found to be more beneficial and convenient to carry out the said objectives between the parties hereto and therefore, the parties have agreed to enter into this MoU under the following conditions.

- 1) Dept. of Philosophy, B. H. College and Dept. of Philosophy, GLC College, Barpeta Road, based upon principles of respect for independence and mutual benefits, shall strongly encourage the following activities:
 - a. Exchanges of Faculty/Staff and Graduate Students;
 - b. Co-organization of and participation in Seminar and academic meetings;
 - c. Cooperate in each other's educational and others program;
 - d. Organizing special short-term academic and educational programs for each other;

- 2) Any activities mentioned above shall be organized and implemented by the Dept. of Philosophy, B. H. College and dept. of Philosophy, GLC College, in due consideration of the following principles:
 - a. Consistent with the policies and the mission of B. H. College and GLC College.
 - b. In accordance with the policies and the mission of B. H. College and GLC College "the right of intellectual property", 'freedom of information and protection of privacy" of respective geographical area.
- 3) B. H. College and GLC College shall be responsible for overall implementation of the MoU.
- 4) Each side shall bear its own costs and expenses arising from this MoU unless otherwise mutually arranged and agreed to.
- 5) The MoU shall be operational with the approval by appropriate Governing Boby/Management committee of their respective institutions.
- 6) Disputes with regard to interpretation of any or all clauses shall be settled by the two nodal authorities. Failing an agreement of the two, a committee having three representatives of each institution nominated by the respective institution, shall resolve the issue in joint meeting(s). The committee shall have the power to recommend modification, annulment, addition, substitution of any clause and/or issue explanatory memorandum that will form part of the MoU.
- 7) Matters not covered under this MoU shall be open for incorporation from time to time subject to mutual consensus of the competent authorities of the two institutions.
- 8) This MoU shall take effect on the date of signatures by the representatives of both the institutions/departments and shall be valid for the period of Five (5) years.

- 10) For each assignment of work to be undertaken by B. H. College and GLC College, under this MoU, the extent of skills and expertise by each of the said institution/department and fee for skills and expertise and faculties to be provided and the terms of payment shall be as per rules of the institutions/departments and in case the skill or expertise is not available it shall be negotiated and be agreed upon by mutual consent. Moreover, they may apply for complementary finance for the programs from other bodies. Similarly, they may apply for funding from national, regional and from international bodies.
- 11) This MoU may be amended or extended by a written document on mutual written consent of B. H. College and GLC College and on approval of the competent authorities.
