The following are the Terms and Conditions of service for the appointees:-

- The services of any selected candidate found to have furnished false/ falsified information regarding educational qualification/ caste/ gender etc. in his/ her application and detected subsequently, will be terminated and legal action will also be taken as per law.
- The appointee shall have to submit joining report in the office of the undersigned on 01.06.2023.
- The appointee also shall also have to furnish Joining Report alongwith an undertaking before the undersigned as prescribed by the **Finance (Budget) Department vide letter No. B.W.3/Pt-II/1, dtd. 25.01.2005** regarding acceptance of "New Pension Scheme" as under:-

"I understand and accept that Government servant joining the service in the State Government on or after 01.02.2005 shall not be governed by the existing Assam Service (Pension) Rules, 1969 and orders issued there under from time to time and that their pension and other retirement benefits will be governed by a set of New Pension Rules, which are being introduced in the line with the Contributory Pension Scheme of Government of India".

- If a Candidate or any of his/her family members is availing benefits under the Orunodoi Scheme at the time of the appointment, he/she or the concerned family member shall voluntarily opt out of the Scheme, as per Orunodoi Guidelines for getting appointment to the post.
- The appointee shall also have to furnish a signed undertaking/affidavit that the time of joining as- *"I,.....(Name), appointed as.....(Designation) in.....Department of Government of Assam do hereby solemnly affirm and declare that, I voluntarily and without duress agree to the terms and conditions mentioned in the appointment order.
