In exercise of power conferred upon the DEE, Assam vide the Govt. letter No. B (3) S 427/2001/3 dated 04/01/2002 and in pursuance of the provision of the Right to Education Act, 2009; the Govt. letter No. PMA. 492/2013/1643 dated 17/06/2016, the Govt. letter No. PMA.261/2015/38 dated 07/07/2015, the Hon'ble High Court order dated 10/03/2016 passed in WP(C) No. 6715/2015, Arup Talukdar & 41 Ors. -Vs- State of Assam & Ors. and as per the Assam Elementary Education (Prov)(Amendment) Rules, 2012 and subject to satisfactory police verification report the following selected candidates are hereby appointed as Assistant Teacher at LP School on purely temporary basis in the Pay Band - 2 (PB-2) @ Rs. 5,200/- to Rs. 20,200/- plus Grade Pay Rs. 2,500/- per month plus other allowances as admissible under the Rules and posted at the school as shown below against their names under the Deputy Inspector of Schools, Barpeta / Bajali. The appointments are purely temporary and may be terminated at any time without assigning any reason thereof. The appointees are to join in his/ her new assignment within 15 (fifteen) days from the date of issue of this order, otherwise the appointment will be automatically treated as cancelled.
